Introduction to Project

PUSS, Palli Unnayan Seva Samiti is a grass-root level voluntary organization, which is registered as a society, working for the benefit of deprived women and girl children since 1985. With inspiration from the freedom fighter and sarvodaya leader Late Ramadevi Chowdhury, Palli Unnayan Seva Samiti was founded by Kadambini Bhuyan at village Naharkanta at the outskirts of Bhubaneswar, the capital city of Orissa.

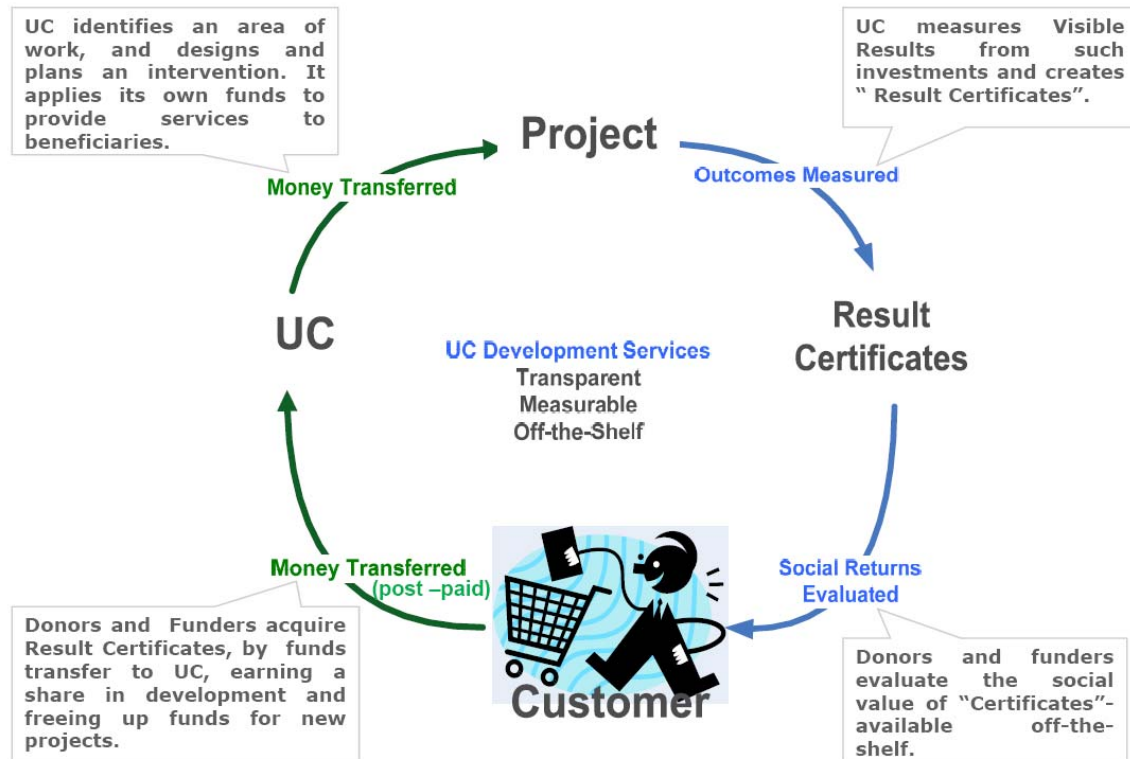
In 1992 Kadambini Bhuyan, decided to do something for even more disadvantaged girl children from other places nearby. She identified 20 little girls from a sexworkers' colony in Orissa, whose mothers were anxious to save them from the same life that they had to lead. PUSS set up a small boarding section for these girls but they needed a regular source of money to support them. Professors Gerry Johnson and Malcolm Harper of Cranfield School of Management, who had been teaching in Bhubaneswar at that time, decided to start Friends of the Children of Orissa. Since then the number of children has risen to almost four hundred and now also includes a small number of little boys whose parents are migrant labourers. For these children, support provided by PUSS is totally redefining their lives. Rama Devi Vidya Mandir is a proposed Girl's High School with a capacity of 450 children from class I to class X which is run by PUSS to educate these children. Currently PUSS is being run under the able leadership of its secretary Ms. Swati Suchismita Patra.

PUSS key focus areas include education, rehabilitation, Income generation , vocational training and health care to support female children. More information about activities and updates about PUSS are furnished in the following link <http://www.pussindia.org/index.html> .

How UC Works?

UC's model aims to improve the scale and efficiency of financing education, health and energy & environmental services for the very poor, through a result-based and post-paid model of funding. What this means is that UC applies its own funds to provide services to beneficiaries. UC then documents the work and presents the results from these projects as Result Certificates. Interested investors and donors are then invited to post-pay for results and acquire these Result Certificates. UC's objective is to generate greater Social Returns for philanthropic investments through this model.

UC's support to the project

Medium of instruction so far in Ramadevi Vidya Mandir high school has been in Oriya medium. Given the backgrounds from these children hail, it becomes increasingly important to ensure smoother transition out from the school. While PUSS has initiated vocational training chapter, their team has recognized the importance of educating the students in English language and also provide them with adequate IT skills. The computer lab infrastructure at PUSS has been created with support from people in Interfinet in Bhubaneswar and Interactive Ideas in UK. UC has agreed to support PUSS with regards to providing resources for IT skills teaching for students in Ramadevi Vidya Mandir high school.

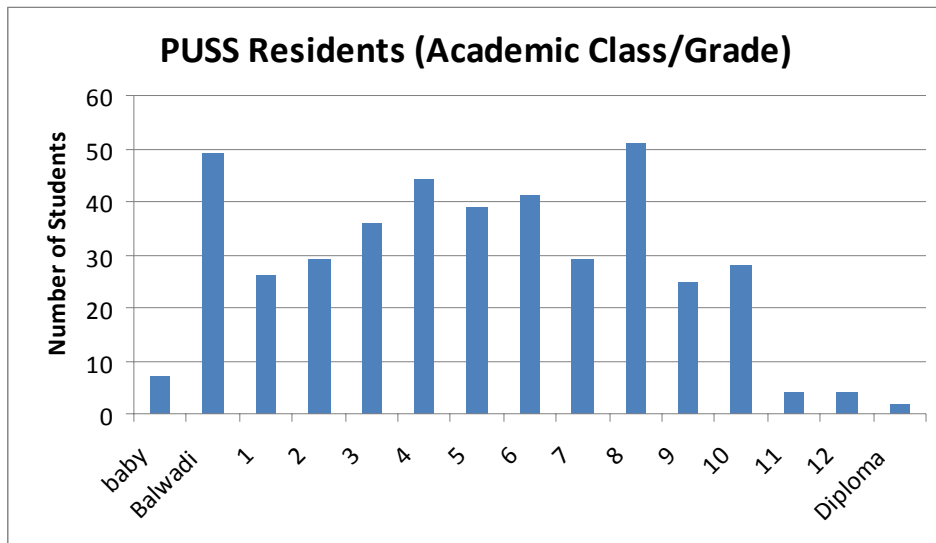
Initial Outcomes of UC's intervention

Apart from meeting the cost of IT teacher for imparting IT skills for students, UC supported PUSS in streamlining the data capturing process of all the children in the school. This resulted in providing some very insightful information about the children including family background information, and from which parts of the state they come from. This intervention also gave understanding about the duration of the stay of all the students at PUSS. PUSS currently supports **414** girl children by providing various services in a residential campus. Most importantly it ensures them a shelter and appropriate ambience for nurturing their growth.

In fact, this was for the first time data related to students has been digitized and comprehensive data base is being created. This proved very helpful to conduct analysis and derive important insights about students on various parameters.

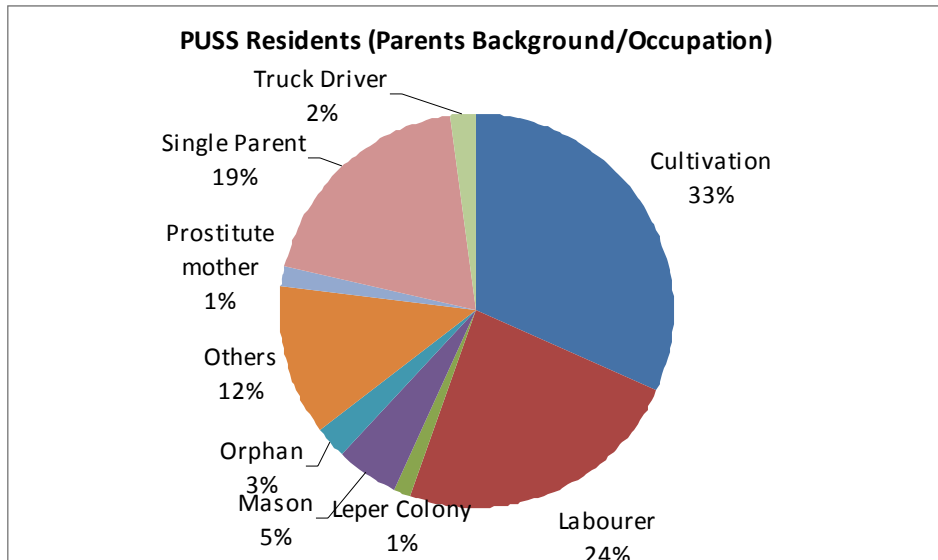
Distribution of students among academic class & grade

PUSS has children enrolled in preschool called Balwadi to couple of the students pursuing their diploma courses. The below graph gives information about distribution of students at various classes.



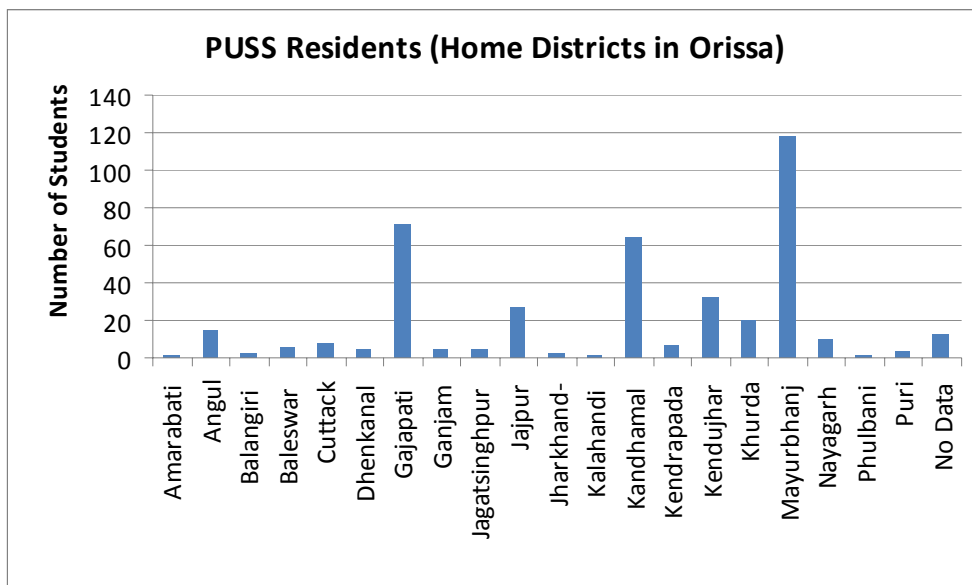
Understanding parents occupation details

Students at PUSS come from very challenging family backgrounds. It becomes all the more important to provide them with long term growth opportunities to avoid any kind of regression into their past conditions. Though initial enrolments into PUSS school were from children from Sex worker families and beggar families, over the time children from families of single parents, daily wage laborers, migrant laborers and cultivators have been enrolled. Below graph provides distribution of children coming from varied occupational backgrounds of their parents.

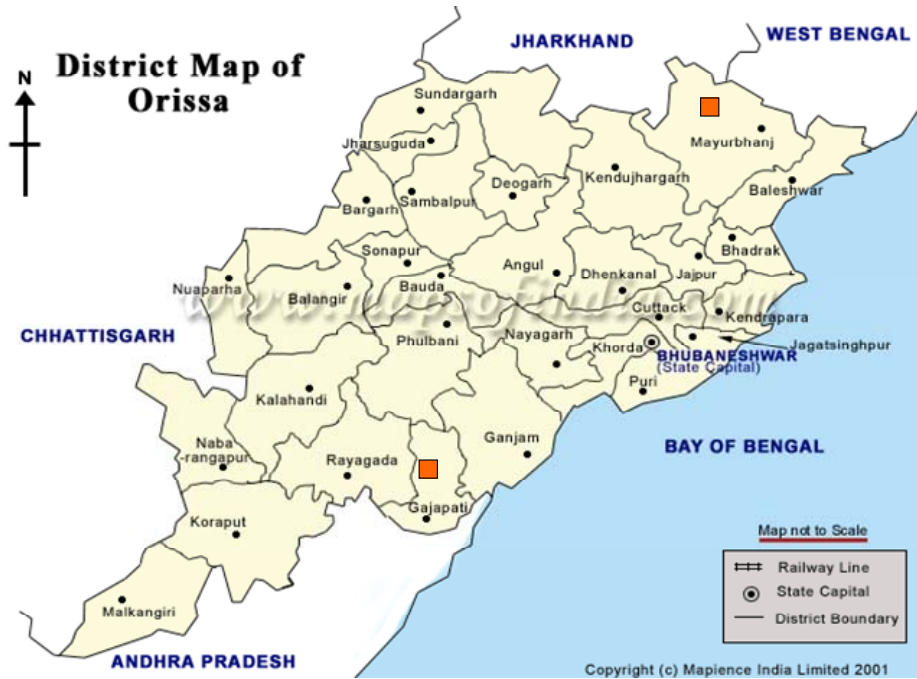


Geographical spread of PUSS students

Students enrolled in PUSS residential school come from as many 20 districts of Orissa state. With maximum number of students enrolled from Mayurbhanj, Ghajapathi and Kandhamal districts. Some of these districts have significant number of tribal population and many students in PUSS also hail from tribal localities.

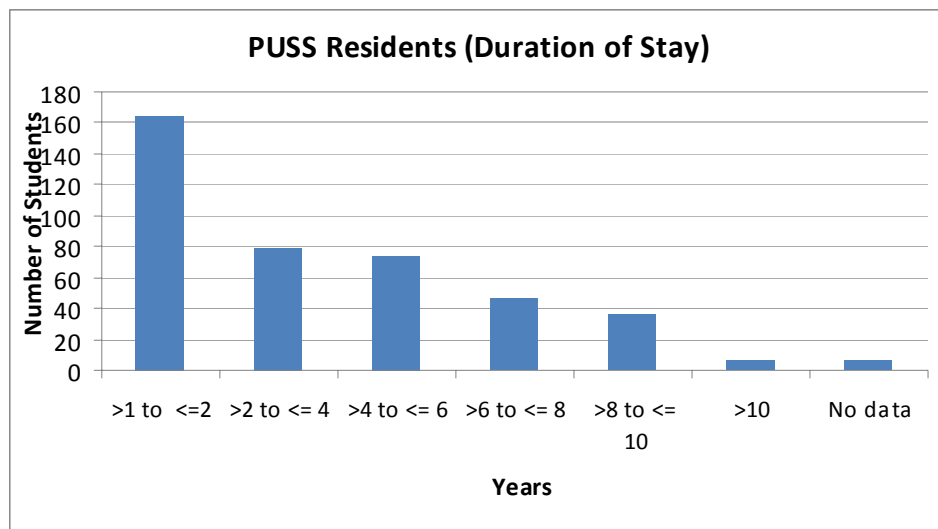


Top 2 districts Mayurbhanj and Gajapati, which have most number of students enrolled into PUSS school , have been highlighted in the Orissa state map furnished below.



Understanding the trends in duration of stay of the resident students

After collating the data, trends of enrolment could be more clearly identified. An increasing number of enrollments have been taking place in the last two years.



These insights about distribution of student community on various parameters is now being leveraged by PUSS management team to review and design strategic plans for further support for children at PUSS.

Providing support for teaching IT skills

UC is currently sponsoring a teacher for teaching IT skills. Ms. Priyadrshini Mishra, is the faculty for IT skills. Children from Class 3 to Class 10 are taking up these classes. Apart from teaching the basics about computer operations, lessons pertaining to Office Applications are also being taught. Currently classes include lessons on Note pad, Paint, Word Document and Presentation software. Note below sample of weekly report for the classes taken between September 27th and 1st of October, 2010.

One of the major constraints in imparting IT education to students is language barrier. All the students underwent their schooling only in oriya medium, this is important constraint that needs to be overcome. UC is currently working to impart basic spoken English skills to the students using e-learning content in the IT lab.

Certification by UC representative

Mr. Gunaranjan UC was personally present at PUSS from 20th to 21st of February, 2010 and from 16th to 18th of August, 2010, for the planning and roll out of activities under this project for this period. Substantial time was spent in designing the data capturing methods for building better data base of students. Evaluation of methodologies to teach IT skills were also discussed with IT faculty.

Conclusion

Going forward UC will primarily focus on developing specific skill sets for IT skills acquisition for the children and start tracking the learning curve of the children against this standard skill set. UC would also like to introduce alternative teaching methodologies to enhance children's comfort levels in speaking English.

Agreement between PUSS and UC

Grant utilisation agreement between United Care Development Services(UC) the Donor and Palli Unnayan Seva Samiti (PUSS) the Grantee made on 18-Aug-2010

Introduction to the Parties:

1. United Care Development Services (website: www.uceee.in), is a not-for-profit company registered under section-25 of the Companies Act, having its office at 9/29, Prashanth Nagar, Boduppal Road, Uppal, Hyderabad-500039.
2. Palli Unnayan Seva Samiti is registered as a Society having its office at PO Naharkanta-752101 Khurda District, Orissa.

Objectives: The purpose of this grant is to introduce result based funding of development work carried out by PUSS. There would be a strong focus to capture data in an organized manner, of various inputs in the Schooling Program run by PUSS for Deprived Girl Children, and to measure results of this program in a quantitative manner. The purpose of this effort is to generate future funding for PUSS based on documented results.

It is hereby agreed that the following **Roles and Responsibilities** will be discharged by the respective parties:

1. UC will support the actual cost of Computer Teacher recruited by PUSS which is capped at Rs. 6,000/- per month for 6 months starting from August-2010 to January-2011.
2. In addition, UC will support at its discretion the cost of any other expenses related to delivery of schooling for children during this 6 month period based on formal agreement exchanged over e-mails with PUSS.
3. In addition, UC may also provide support to the schooling program run by PUSS in, kind including fixed assets. It will be the responsibility of PUSS to take due care and maintenance of any such assets given by UC.
4. UC will from time to time advice and provide training to PUSS staff, for introducing innovations, improvements and best practices, in the social development activities carried out by PUSS, in order to achieve greater results for the efforts and resources being put in.
5. PUSS will submit regularly to UC, data of students, their progress in academics and any other data required to evaluate the social impact of the work carried out by PUSS, in a format and frequency as agreed upon mutually.
6. PUSS will submit to UC, copies of bills and vouchers of expenses covered by the Grant from UC.
7. PUSS will not claim from other Donors the expenses covered by the Grant from UC.
8. PUSS authorizes UC to share reports of work carried out by PUSS in UC's public documents, including its website, in order spread awareness of the work being carried out at PUSS.
